With the mandatory water reductions that I read about last night in a letter from Apple Valley Ranchos, I am in a bit of a pickle here at the building. According to Town code, I am required to keep our landscaping watered and alive. However, with Apple Valley Ranchos implementation of a 3 day a week watering schedule, I run the risk of not being able to provide enough water to the plants to keep them alive.

At the end of the day, with as critical of an issue that water has become, I feel like the responsible thing to do is to turn off my irrigation all together. I understand the Town's stance of wanting businesses in the Town limits to maintain a certain appearance, but being so far away from "civilization," I am not sure anyone would notice if our landscaping was to die. It seems crazy to use water to grow plants and trees in the Mojave Desert.

Included in the documentation that Ranchos sent, it did provide and option of writing a letter to gain an exception. I can go that route if the Town's code supersedes the mandatory restrictions.

With that said, I wanted to get your thoughts on our exposure with the Town if I begin to have plants die and also on just turning the water off completely.
