### **RESOLUTION 2008-27**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY, SAN BERNARDINO COUNTY, CALIFORNIA. OPPOSING APPLICATION NO. 08-01-002, AN APPLICATION WITH THE CALIFORNIA **PUBLIC** COMMISSION (CPUC) BY APPLE VALLEY RANCHOS WATER COMPANY, A PRIVATELY HELD PUBLIC UTILITY, SEEKING AUTHORIZATION TO INCREASE RATES CUSTOMERS IN THE TOWN OF APPLE VALLEY AND SURROUNDING AREA BY MORE THAN 25% OVER A THREE YEAR PERIOD.

**WHEREAS**, the Apple Valley Ranchos Water Company is the major water service provider within the Town's corporate boundary; and

**WHEREAS**, the Apple Valley Ranchos Water Company enjoys certain California Public Utility Commission (CPUC) State granted protections against competition from other water service providers, regardless of cost; and

**WHEREAS**, the rates proposed by the Apple Valley Ranchos Water Company are not subject to review, approval by the Town Council of the Town of Apple Valley, or a Proposition 218 challenge, as is provided for rate setting purposes for public agency water and sewer service providers; and

**WHEREAS**, a request for return on investment exceeding 10%, in a time of economic recession and when the State budget shortfall is projected to exceed \$18 Billion is unreasonable; and

**WHEREAS**, the request for increase is unreasonably based in part on declining consumption by the Apple Valley Ranchos Water Company customer base, which if found valid will, in theory, lead to increases in rates to a point when the customer would pay a water rate even if they use no water; and

**WHEREAS**, the rules of the CPUC, as described by the Apple Valley Ranchos Water Company prohibits the logical company-funded capital expansion of its distribution system to currently underserved areas, which would reduce the impact of reduced consumption on revenue generation by adding new customer base; and

**WHEREAS**, the Apple Valley Ranchos Water Company enjoys a State guaranteed rate of return on investment without regard to its fitness to serve or its efficient operation; and

WHEREAS, the rates currently authorized by the CPUC for collection by the Apple Valley Ranchos Water Company exceeds that of surrounding public agency purveyors, by as much as 100% who all pump the same water from the same aquifer, makes the current rates unreasonable without the proposed increase.

**NOW, THEREFORE, BE IT RESOLVED** that the Town Council of the Town of Apple expresses its clear and complete opposition to the proposed rate increase application (Application No. 08-01-002) as filed by the Apple Valley Ranchos Water Company as unreasonable.

**BE IT FURTHER RESOLVED** that the Town Council requests that the California Public Utility Commission rate filing procedure be modified to bring the public utility rate making process into conformance with the proposition 218 rate setting requirements as required of public agencies.
