ORDER EXTENDING STATUTORY DEADLINE

Summary

This decision extends the statutory deadline in this proceeding to June 29, 2019.

1. Background

Based on the filing date of this Application, the version of Pub. Util. Code § 1701.5(a)¹ then in effect provided that ratesetting cases shall be resolved within 18 months of the date the scoping memo issued, unless the Commission establishes an alternative timeline in the Scoping Memo or issues an order extending that deadline. On December 28, 2016, the Scoping Memo was issued in this proceeding setting the statutory deadline for June 29, 2018. Decision (D.) 18-06-035 issued on June 21, 2018, extended the statutory deadline to December 29, 2018. This decision further extends the statutory deadline of this proceeding to June 29, 2019.

¹ This proceeding was filed prior to changes made to Pub. Util. Code § 1701.5(a). These changes only apply to cases filed after December 31, 2016.

On April 8, 2016, CereTel Incorporated (Applicant) filed this application seeking authority to operate as a Non-Dominant Interexchange Carrier Telephone Corporation pursuant to Public Utilities Code § 1013. The application was protested by the Commission's Safety and Enforcement Division (SED) and after identifying several violations, SED questions Applicant's fitness to operate in California. A Prehearing Conference was held on December 5, 2016. An Evidentiary Hearing was held on June 15, 2017.

The assigned Administrative Law Judge has issued two rulings requesting the applicant to submit additional information. An extension of time beyond the current statutory deadline of December 29, 2018, is necessary to prepare the proposed decision of this proceeding. Therefore, the statutory deadline of this proceeding is extended until June 29, 2019.

2. Waiver of Comment Period

Under Rule 14.6(c)(4) of the Commission's Rules of Practice and Procedure, the Commission may reduce or waive the period for public review and comment of proposed decisions extending the deadline for resolving ratesetting proceedings. Accordingly, the otherwise applicable period for public review and comment is being waived.

3. Assignment of Proceeding

Carla J. Peterman is the assigned Commissioner and Debbie Chiv is the assigned ALJ in this proceeding.

Findings of Fact

1. This application was filed on April 8, 2016 and protested by the Commission's Safety and Enforcement Division on May 12, 2016.
2. On December 28, 2016, the Scoping Memo was issued in this proceeding setting the statutory deadline for June 29, 2018

3. Decision 18-06-035 issued on June 21, 2018, extended the statutory deadline to December 29, 2018.

4. The assigned Administrative Law Judge has issued two rulings requesting the applicant to submit additional information. An extension of the statutory deadline is necessary to prepare the proposed decision of this proceeding.

Conclusion of Law

Pursuant to the authority granted to the Commission under Pub. Util. Code § 1701.5(a), the statutory deadline should be extended to June 29, 2019.

IT IS ORDERED that:

1. The statutory deadline in this proceeding is extended until June 29, 2019.
2. Application 16-04-006 remains open.
